

POLICY STATEMENT ON IMMUNIZATION OF URJ CAMP AND IMMERSIVE PROGRAM PARTICIPANTS

Vaccination has a Jewish context and is a shared responsibility and an expectation for all members of our URJ community. URJ policy is aligned with the childhood, adolescent, and adult immunization schedules published by the American Academy of Pediatrics, the Canadian Paediatric Society, and the US Centers for Disease Control & Prevention (CDC). These schedules are widely recognized as the standards of care across North America. Among our most cherished Jewish values is the imperative for preserving life and maintaining health. We embrace this value specifically by taking these and other preventive measures to protect the public health of our URJ communities. Parents entrust the URJ and have high expectations for their children’s experiences in our camps and programs. All the fun, friendship building, Jewish identity affirmation and character development can only happen if we are confident that individual safety and public health remain at the center of our decision-making. Reducing the risk of vaccine-preventable illnesses from entering any of our camps or programs is simply the single most effective strategy to protect public health.
